# ADOPTED UPSHUR COUNTY FY 18 BUDGET

This budget will raise more revenue from property taxes than last year's budget by an amount of \$719,887 which is a 6.8% increase. The property tax revenue to be raised from new property added to the tax roll this year is \$183,163.
