## ADOPTED UPSHUR COUNTY FY 19 BUDGET

This budget will raise more revenue from property taxes than last year's budget by an amount of \$211,995 which is a 1.9% increase. The property tax revenue to be raised from new property added to the tax roll this year is \$99,752.
